## Financial/Administrative: (Fiscal Officer's report)

- 1. Trustees reviewed invoices, signed checks and vouchers, reviewed and initialed payroll, reviewed and signed purchase authorizations.
- 2. The SAM renewal is being worked on by Mike McGinnis and must be completed by July 31, 2022.
- 3. The Ottawa County Health Department certified \$9,103.08 to be budgeted for 2023, a decrease of \$233.48 from 2022.
- 4. The annual assessment from Regional Planning was received in the amount of \$964.80.

### **Cemetery**: (Sexton's report)

- 1. A voluntary recall notice was received on the Intimidator: Water can get into the throttle cable and freeze at low ambient temperatures resulting in a stuck throttle causing the UTV to fail to stop when brakes are applied.
- 2. A request for a burial to take place on a Sunday was denied, which was in accordance with the cemetery policy.
- 3. Top soil was obtained and will be seeded on ruts and plots as needed.

### Roads: (Road Superintendent's report)

- 1. An informative meeting on road projects is scheduled for July 12 at the Ottawa County Engineer's Office.
- 2. Linker-Harder road improvements, including resurfacing, are to be started the week of July 11.
- 3. A cement mixer being stored and taking up needed space in the township garage is no longer being used to form cemetery bases. It will be offered for auction on Govdeals.
