- 2. A motion was made by Trustee Greenhill and seconded by Trustee J Haar that the attached list of bills totaling \$45,130.29 be approved as the lawful obligations of Harris Township and that the Fiscal Officer be permitted to issue warrants in favor of the same. **Motion carried**.

2. Fiscal Officer reported that she has been contacted regarding the commencement of the full audit over fiscal years 2021 and 2022. Trustees waived a pre-audit meeting. A purchase order will be issued in the estimated amount of \$4,920.00 from the General Fund.

 - b. \$13,356.60 from EMA ARPA Ohio First Responder Recruitment

- 1. A contact was made from Blue & Co. LLC regarding the Medical Ground Ambulance Data Collection System.
- 2. Radio equipment no longer compatible with township EMS radio systems was donated to the Village of Elmore.
- 3. McGinnis recommended replacing the two remaining keyless locks in the building, located at the exterior and interior EMS doors at a cost of \$2,200 each plus installation by Northcoast around \$425 each. The locks could be programmed remotely, allowing "mobile alerts" in addition to the security cameras, as well as remote programing. The current keyless locks are nearing 10 years of use. Trustees considered replacement; however, unanimously agreed to table the decision due to pending building modifications.
